



CHARTE CARTE PRIVILEGE

CAPITAINERIE DU PORT DE SAINT-TROPEZ

This Charter sets out the principles, undertakings and benefits attached to the **PRIVILEGE Card**, issued by the Port Authorities of the Port of Saint-Tropez.

1. Purpose of the PRIVILEGE Card

The purpose of the PRIVILEGE Card is to grant its holders preferential conditions of service and bookings within the Port of Saint-Tropez, as well as exclusive benefits, in strict compliance with port regulations and applicable legal provisions.

2. Obligations of the Cardholder

The holder of the PRIVILEGE Card undertakes to:

- Subscribe to and renew the PRIVILEGE Card for a firm period of three (3) consecutive years for any contract entered into as from 1 January 2026;
 - Settle the amount due for the purchase or renewal of the Card within fifteen (15) days from the date of issue of the invoice;
 - Subscribe to or renew the Card no later than 31 March of the relevant year;
 - Comply with the **Specific Port Police Regulations of the Port of Saint-Tropez (RPPP)**, as well as all provisions applicable within the territory of the municipality of Saint-Tropez.

3. Pricing Conditions

- The annual price of the PRIVILEGE Card is set at **ten thousand euros inclusive of all taxes (€10,000 incl. VAT per year)**, in accordance with Resolution No. 2025/235 dated 8 December 2025;
 - This price may be revised annually in line with changes in the INSEE index for the previous year (year n-1).

4. Benefits Attached to the PRIVILEGE Card

4.1. Overnight Berth Reservations

The PRIVILEGE Card entitles its holder to the following:

- Six (6) overnight stays in the Port of Saint-Tropez in July;
- Six (6) overnight stays in the Port of Saint-Tropez in August;

- In the event of berth unavailability in the port, particularly in July and August, PRIVILEGE Card holders may register on the waiting list at any time;
- The possibility of retaining their position on the waiting list even in the event of cancellation of one day.

Reservations are made in accordance with the procedures and time limits defined in the RPPP, subject to berth availability within the port.

4.2. Additional Benefits

The Cardholder also benefits from:

- One (1) personal, named card included in the package;
- Two (2) access cards to the Port parking facilities, allowing access to the Capitainerie parking area for two identified vehicles;
- Access to the “Saint-Tropez Lounge Club”;
- Specific conditions relating to the payment of deposits:
 - A period of thirty (30) days to pay the deposit and confirm a reservation;
 - A reduced period of ninety-six (96) hours when the arrival date of the stay is less than fifteen (15) days away ;

The Municipality reserves the right, where applicable, to offer additional services.

5. Conditions of Use

- The PRIVILEGE Card is issued for a specific vessel;
 - It is unique, strictly personal and non-transferable;
 - Any abusive, fraudulent or non-compliant use of the Card may result in the suspension or withdrawal of the benefits attached to the PRIVILEGE Card.

6. Undertakings of the Port Authorities :

The Port Authorities of Saint-Tropez undertakes to:

- Provide a level of reception and service consistent with the standards and image of the Port of Saint-Tropez;
 - Inform Cardholders of any changes or amendments relating to the PRIVILEGE Card.

7. Entry into Force

This Charter shall enter into force as from the date of payment of the PRIVILEGE Card by the Cardholder.

Subscription to the PRIVILEGE Card constitutes full, complete and unconditional acceptance of all the provisions of this Charter.
